Anyone that has ever attended an event in Villa Rica is likely to have seen photographer **Michael Valentine** out capturing Villa Rica's moments that include buzzer beaters, walk-off hits, winning goals, concerts, award presentations, ribbon cuttings and speeches.

Valentine has been doing photography for around nine years in Villa Rica. He had also previously done



photography before moving up to Villa Rica but did not have the time that he has now. During his time photographing in Villa Rica, Valentine has captures thousands of faces

Valentine talked about what got him into shooting photography in Villa Rica and said, "I would think that it was probably the downtown concerts and festivals along with the car shows and trains that really got me going in Villa Rica along with the free time that comes with retirement."

Does Gas Go Bad?

Anyone who has operated gas engines, especially small engines on lawnmowers, pressure washers, etc., or fooled around with old cars or trucks, knows what "bad" gas smells like. It doesn't smell like gas, more like sour oil based paint. So there is no question that it changes properties, but is it bad? After pulling my arm off trying to start small engines on stale or bad gas, I can assure you that it doesn't work like it did when new!

My normal routine when putting away small gasoline equipment at the end of the season is to start the engine, turn off the gas line, and wait for the engine to stall after consuming all of the fuel in the carburetor and lines. Then I turn off the gas line, and fill the tank with fresh stabilized non-ethanol gas. This usually results in an engine that starts after only a few pulls in the springtime. (A real mechanic would clean the plug and change the oil too.)

Recently I was dismayed to pull out my pressure washer to find that I had not followed my normal routine when storing it for the winter. The gas line was left on, and the tank was almost empty, just like I left it last spring! (I guess I thought I was going to use it again?) The only good news is that I only use stabilized non-ethanol gas in my small engines yearround. But still, experience told me that filling the tank and pulling that rope was probably useless. Instead, I filled the tank with fresh non-ethanol gas, and drained the bowl on the carburetor. What came out looked like a diluted orange drink, instead of the light yellow of gasoline. When it started changing color, I closed the bowl and pulled the starter rope. After several tries it started and ran fine.

Following is an Rislone article that confirms what most of us know from experience. It takes my story a bit further and talks about our old cars, which are built a lot like that pressure washer, complete with metal gas tanks, rubber lines, and carburetors. Nick

DOES GASOLINE GO BAD?



We get this question all the time on our tech support lines and on Facebook.

For most of us, gasoline never seems to sit around for very long. But when you do store gas or go a long time without using it, the question arises: does gas go bad? Let's take a closer look at the shelf life of gasoline and what can happen when you store it for too long.

Does Gasoline Expire?

The answer is yes. How long does gas last? That depends on a variety of factors, such as what type of fuel it is and how and where it is stored. Heat, oxygen and humidity all have an impact on the condition of stored fuel.

In general, pure gas begins to degrade and lose its combustibility as a result of oxidation and evaporation in three to six months, if stored in a sealed and labeled metal or plastic container. Ethanol-gasoline blends have a shorter shelf life of two to three months. Fuel stabilized gasoline can last between one and three years under optimal conditions. Gas stored in a car tank begins to degrade in just about a month.

The Dangers of Using Old Gas

Old gas does not become contaminated necessarily, but rather loses its combustible properties and volatile compounds. When you use gasoline that's too old, it can damage internal engine components. It may also start to form a gum residue that could cause blockages. If there's ethanol in the fuel, it may draw water vapor into your fuel line, which could result in internal corrosion.

How to Properly Store Gas to Make It Last

Gasoline should be kept in an airtight container. You should always label when the gas was purchased and stored. Keep gas in a cool, low-oxygen environment. If your stored gas becomes exposed to high heat and humidity, it can increase the volatility and potential for fire and explosion. For this reason, having a container with more than five gallons of fuel is not recommended.

When you have an automobile, machine or piece of equipment with a full tank that's idle for a prolonged period, using a fuel stabilizer additive is the easiest, most efficient way to help keep its potency.

Identifying Old Gas

Labeling, properly storing and knowing how long it takes for gasoline to go bad is your first line of defense against using fuel that's too old. When in question, check the color of the gas compared to fresh fuel. As gasoline ages, it tends to darken in color. The smell of gas can also be a dead giveaway that it's past its prime. If you detect a sour scent or it smells spoiled, it's an indicator that the gas has gone bad.

Editor's addendum

We all probably have our favorite ways to dispose of old stale clean gasoline, some legal, and others questionable. But in researching the article I came across a majority of articles that indicate that mixing old gas 1 to 4 with fresh gas usually results in a suitable mixture for small engines or your daily driver. It is likely that the octane rating of the mixture has dropped a bit, and an octane booster may be advisable if you are running this in a higher compression car engine.

I keep a 5kW generator at home, gassed up and ready to go at a moment's notice. It has a large fuel tank full of non-ethanol, stabilized, gasoline. At the end of every summer, headed into the icy winter, I siphon the gas into a clean container and pour it into my daily driver. Easy disposal at about 17 mpg! Then I refill the generator with fresh non-ethanol gas and a good stabilizer. If I run out of gas during an icy storm, and the service stations are closed, I have about 60 gallons of stabilized non-ethanol gas that I can borrow from three old cars! Nick
